WHEREAS, the Declaration, as a result of an inadvertent error, mistakenly included and/or failed to exclude certain real property described herein from the "Property Subject to Declaration" described in Article I, Section 1.01 of the Declaration;

WHEREAS, Article VIII, Section 8.04.2 of the Declaration provides that the Board of Directors of Westgrove Court Community Association, Inc. (the "Association") has the right to amend the Declaration without joinder of any Owner or any other Person in order to correct any inadvertent misstatements, errors or omissions in the Declaration;

WHEREAS, the Board of Directors of the Association desires to amend the Declaration in order to rectify the inadvertent error described herein above; and

WHEREAS, the Board of Directors of the Association, with a quorum of Directors present at a duly-noticed and called meeting of the Board of Directors, did vote to adopt, consent to and approve the terms of this First Amendment to Restated and Amended Declaration of Covenants, Conditions, Restrictions and Easements for Westgrove Court on the 24th day of June, 2019;

NOW, THEREFORE, Article I, Section 1.01 of the Declaration is hereby deleted in its entirety and replaced with the following:

> SECTION 1.01 Property Subject to Declaration. The real property which, by the recording of the Declaration, will be held, transferred, sold, conveyed, used, occupied, and mortgaged or otherwise encumbered subject to the Declaration is that certain real property located in Harris County, Texas, more particularly described as follows, to wit:

WESTGROVE COURT, an addition in Harris County, Texas according to the map or plat thereof recorded in Volume 27, Page 75, Map Records of Harris County, Texas, SAVE, EXCEPT AND EXCLUDING, Lots One (1), Two (2), Seventeen (17) and Eighteen (18), in Block One (1), and Lots One (1), Two (2) and Twenty-Four (24), in Block Two (2).
